PARTICIPANTS MUST BE PRE-REGISTERED.

THE ENROLLMENT FEES MUST BE PAID IN ADVANCE. PAYMENT CAN BE SENT BY MAIL OR PAID IN PERSON AT THE SHERIFF'S OFFICE DURING NORMAL BUSINESS HOURS

PAYMENT MUST BE CASH OR CHECK, WE ARE UNABLE TO ACCEPT CREDIT OR DEBIT CARDS

PAYMENT MUST BE MADE AT LEAST 48 HOURS BEFORE THE CLASS BEGINS

THE CLASS IS FULLY REFUNDABLE UNTIL 48 HOURS BEFORE THE CLASS BEGINS. NO REFUNDS WILL BE GIVEN WITHIN 48 HOURS OF THE TIME THE CLASS BEGINS. THIS IS NECESSARY TO DETERMINE THE NUMBER OF INSTRUCTORS THAT WILL BE NEEDED.

CASH WILL BE ACCEPTED AT THE OFFICE DURING NORMAL OFFICE HOURS MF, 9-5. PLEASE DO NOT MAIL CASH. PAYMENT MUST BE RECEIVED 5 DAYS PRIOR TO THE CLASS DATE.

THIS COURSE WILL BE INSTRUCTED BY THE SAME FIREARMS INSTRUCTORS THAT TEACH THE MEN AND WOMEN FROM THE OFFICE OF THE SHERIFF. TOGETHER, THIS GROUP OF INSTRUCTORS HAS A COMBINED TOTAL OF OVER 150 YEARS OF LAW ENFORCEMENT EXPERIENCE AND OVER 60 YEARS AS FIREARMS INSTRUCTORS. THE GROUP ALSO HAS A COMBINED 60 YEARS IN SPECIALIZED TRAINING AS MEMBERS OF THE EMERGENCY RESPONSE TEAM. IN ADDITION TO THIS, EACH INSTRUCTOR IS NRA CERTIFIED
